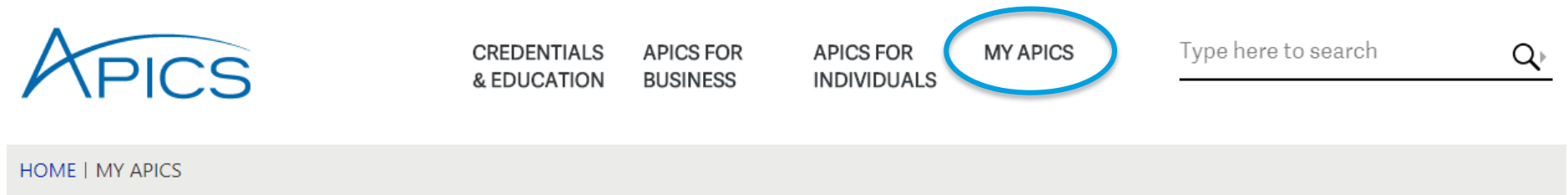

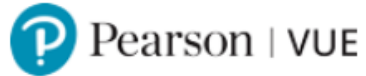



If you wish to make any changes to your name, you must contact APICS directly at exams@apics.org. Pearson VUE cannot make any changes to your name in the system.

No personal items may be taken into the testing room. This includes all bags, books not authorized by the sponsor, notes, phones, pagers, watches and wallets.

Pearson VUE global test policy changes

In order to preserve the security and integrity of examination programs, Pearson VUE test administrators (TAs) may request visual inspection of eyeglasses and other materials brought into the Pearson VUE testing room. Candidates will be required to allow TAs to examine materials in order to begin the check-in and examination process, including the removal and visual inspection of eyeglasses. Candidates who do not comply with this global security policy may not be admitted to begin their APICS examination. Candidates who bring personal items such as Google Glass, will need to store them with their remaining personal items or keep them in their vehicles in order to continue the check-in process.

Reschedule Policy

Candidates must reschedule their examination more than 24 hours prior to their exam appointment. Candidates can reschedule through their My APICS account or by contacting Pearson VUE directly. APICS does not accept reschedule requests.

Once an exam authorization is scheduled, appointments can only be rescheduled within their authorization period. Rescheduling the exam does not extend the authorization period.

Candidates who need to reschedule their exam appointment can make modifications directly in their My APICS account under the Exam Authorization and Credits section or by calling Pearson VUE directly. There is a non-refundable USD \$45 rescheduling fee. Call center fees will also apply if rescheduling by phone. If the candidate does not sit for the test, the exam fees are forfeit.

Scheduling Instructions

Candidates can access the scheduling/rescheduling function for their exams online at any time through their My APICS account by following instructions below:

- Login into your My APICS account
- Click on MY APICS at the top navigation
- Scroll down to the My APICS Certification section and navigate to Exam Authorizations and Credits
- Select the schedule/reschedule hyperlink next to your exam

Cancellation Policy

Candidates can only reschedule their exam. Please see reschedule policy.

Additional Information

Exam fees are forfeited for no-shows. Exceptions may be made for medical or other emergencies. If candidates miss the exam due to an emergency, they must contact Pearson VUE within 10 business days after the exam date. Pearson VUE contact information can be found at Pearson VUE Customer Service. Candidates must submit written documentation to Pearson VUE in order to have their request reviewed. Only authorized emergencies will be considered. Additional information regarding all APICS examinations can be found by visiting APICS Exam Handbook (www.apics.org/handbook).

A service fee of \$10 will be applied to all reservations, reschedules or cancellations completed by the Pearson VUE Call Center. This fee will be in addition to any applicable reschedule or cancellation fee.

APICS Policies

Admission Policy

Candidates must check in at the test center no later than 15 minutes before their scheduled appointment. Candidates who arrive past this time may be refused admission to the test center and may lose their exam appointment. Furthermore, they may be considered a no-show and may forfeit the full exam fee. We recommend that you become aware of the route and location of your exam site prior to your scheduled appointment.

You will need to bring two (2) forms of identification to the testing site. The first and last names on the primary and secondary identifications presented at the test center must match the first and last names identified in this email in order to receive admittance to the testing center. If you do not bring the required, valid IDs on exam day or the name above does not match your IDs, you will be denied admission to the examination and will forfeit the exam fee.

Candidates must bring a valid primary identification, bearing a future expiration date that includes a recent photograph and signature:

- driver's license (except in China)
- passport
- military ID
- state ID
- company ID (except in China)
